1. - The firms are required to mention bifurcated rates showing the detail of b asic rates and GST in their bid. GST on the <u>ORDERED / CONTRACTED IT</u> <u>EM</u> will be paid extra as applicable. In case, the supplies are delayed by t he firm beyond the stipulated delivery period & there has been any upwar d revision in the taxes/duties <u>ON THE CONTRACTED ITEM</u>, no such incre ase will be allowed. However, if there has been any reduction in taxes/duties, the same will be availed.
