1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
2. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU / Public Listed Company for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in

support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

3. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

4. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY. 5. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 20% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU / Public Listed Company. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

6. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
- v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

3. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

4. Turnover

Bidder Turn Over Criteria: The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

5. Turnover

6. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

(i) Only OEM/OEM Authorized dealers of M/s Hughes Communication India Ltd (HCIL) can participat

e in subject bid as items are proprietary in nature. Other authorized dealer/sellers/Re-sellers shall not participate against this bid and same will be rejected. No representation in this regard will be entertained.

(ii) **PAC:** The proposed stores are being procured as per Rule 166(iii), Chapter-6 of General Financial Rule 2017 for the purpose of standardization of machinery or spare parts to be compatible to the existing sets of equipment in connection with re-activation of defective satellite equipment

(iii) **Mention of Make & Model of offered product field on GeM portal:** The seller should clearly mention the offered Make & Model of the product in appropriate field on GeM portal during bid submission failing which the bidder offered product will be rejected and seller shall be disqualified. No representation in this regard will be entertained.

(iv) **Delivery condition:** Bidder needs to install and commission the supplied items with all required sites at 1056 Fd Wksp (Km 148.000) on D-S-DBO Road in the AOR of HQ 50 BRTF within **90 days** from the date of placing of GeM contract order.

(v) Bidder to furnish Non-disclosure Certificate (on bidder letter head) with bid reference

(vi) Past performance (20%) of bid value for same or similar category items during last 3 years

(vii) Information/Undertaking of Court cases/Arbitration/Non-blacklisting to be furnished by the bidder and should also furnish certificate confirming that bidder should not be a habitual litigant (with bid details)

(viii) OEM/Bidder Turnover Certificate for last 03 years duly verified by CA

(ix) The supplied item will be measured & inspected prior to acceptance. The material if not found as per desired specifications and norms are liable to be rejected and the rejected item has to be lifted by the supplier at his own risk and cost.

(x) Agreement by bidder for all terms and conditions of bid (with bid reference)

(xi) In case of any doubt on the seller submitted relevant documents and experience supply orders are

liable to be verified by the BOOs and Competent Authority. If found incorrect/Fake and become L1, not supply items as specified within stipulated time frame the bidder shall be blacklisted for 03 years.

(xii) **Rejected stores:** All rejected stores are liable to be back loaded by seller within seven days from consignee location at his own risk and cost in case of stores are not accepted/rejected by TBO

(xiii) **Cancellation of Bid:** Competent Authority will have the right to cancel the bid at any stage of procurement process including after opening of Financial Bid and Reverse Auction without assigning any reason to seller. No representation in this regard will be entertained.

(xiv) **Payment terms & Conditions:** Payment will be released after successful completion of supply and installation/commissioning of stores as per GeM terms and conditions.

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process.
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
