In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
2. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. 3. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU / Public Listed Company for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
4. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
5. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY. The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017.
6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
7. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 50% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU / Public Listed Company. 9. The BUYER does not bind himself to accept the lowest quotation or any other quotation and reserves the right to accept or reject any of the quotation either in part or in full without assigning any reasons whatsoever to.
10. Rates shall be quoted for delivery at the location specified BY THE BUYER at the responsibility of the supplier. **The rates quoted by the firm shall be inclusive**

ive of packaging charges, cost of insurance, loading/unloading, transportation charges and all incidentals for delivery at consignee location.

The rates quoted for various stores/items shall however be the basic rates exclusive of any taxes. Taxes shall be quoted separately. In case, bidder do not indicate separately the relevant taxes/ duties likely to be paid in connection with delivery of uploaded goods, the total cost quoted by them will be taken into account in the ranking of bids.

–

11. Pamphlets / leaflets / sketches / samples of the product for which rates are being quoted showing specifications thereof shall be enclosed with the quotation. This will however not be returnable.

–

12. Discount, if any, offered thereon shall be clearly specified.

–

13. No adjustment in the rates after the date of opening of the quotation on account of any increase/decrease in the cost of input or on account of any statutory increase in any taxes or duty is admissible.

–

14. Period of warranty, if any, being offered for the product shall be specified clearly. Min warranty should be of six months for the product being supplied.

15. The inspecting authority will be a Board of Officers convened by consignee unit and inspection will be done at consignees/delivery location. Stores rejected by BOO shall be lifted by supplier under own expenses.

16. The BUYER however reserves the right to subject the stores to a second inspection by an authority nominated by him or to inspect the stores himself within four months from the date of acceptance.

–

17. In case your firm fails to supply the stores within the time specified in the supply order or any extension thereof, you shall be liable to pay liquidated damages (LD) at the rate of a sum equivalent to 0.5% per week or part thereof for undelivered portion of supply subject to maximum 10% of the value of supply order.

–

18. The Govt Departments are generally exempted from levy of town duty, toll tax, octroi duty, terminal duty or other levies of local bodies. A road entry permit to this effect will be issued by this Department with the supply order on the request of firm.

19. The Supplier should submit GST clearance certificate at the time of payment of their respective bill.

20. STANDARD CONDITION FOR QUOTATION: The Supplier is required to give confirmation of their acceptance of the following standard conditions: -

(i) LAW: The Supply Order shall be considered and made in accordance with the Laws of Republic of India. The Supply Order shall be governed by and interpreted in accordance with the Laws of Republic of India.

(ii) EFFECTIVE DATE OF THE SUPPLY ORDER: The supply order shall come into effect on the date of signature of accepting officer. The deliveries and supplies and performance of the services shall commence from the effective date of the supply order.

(iii) SAMPLE: Samples should be got approved by the competent authorities in case of ambiguity, and shall be enclosed with quotation, if required. In case items of specific Make/Brand is required the supplier must confirm to IS specification. Approved sample (Wherever mentioned are kept in sample room at HQ 1051 Fd Wksp (GREF).

(iv) AMENDMENT: No provision of the supply order shall be changed or modified in any way (including this provision) either in whole or in part except by an instrument in writing made after the date of the supply order and signed on behalf of both the parties and which expressly states to amend the supply order. In case of any ambiguity, clarification/amendment required, shall be discussed in pre bid meet, before submitting Financial Bid .

(v) REJECTED STORES: All rejected stores are liable to be back loaded to the Supplier concerned from consignee location at risk and cost of the firm (in case stores not accepted/found correct by consignee/collection party).

(vi) NOTICES: Any notice required or permitted by the Supply Order shall be written in the English language and may deliver personally or may be sent by Fax or registered pre-paid mail/e-mail, addressed to the last known address of the party to whom it is sent. **Supply order will be sent on GeM.**

(vii) SCHEDULE OF REQUIREMENT: NA.

(vii) TECHNICAL DETAILS: The item shall conform to Technical Specifications.

(ix) NON-DISCLOSURE OF SUPPLY DOCUMENTS: The Supplier shall not disclose the content of the quotation or any provision, specification, sample, design or information thereof to any third party.

(x) TERMINATION OF SUPPLY ORDER: The BUYER have the right to terminate the Supply Order in part or full in any of the following cases: -

- (a) The delivery of the material is delayed for the courses not attributable to Force majeure for more than **45 days** after the scheduled date of delivery.
- (b) The Supplier is declared bankrupt or become insolvent.
- (c) The delivery of material is delayed due to Force majeure by more than 90 days.
- (d) The buyer has noticed that the seller has utilized the services of any Indian/Foreign agent in getting supply order and paid commission to such individual/company etc.

21. OCTROI DUTY & LOCAL TAXES

(a) Normally, materials to be supplied to Government department against Government Supply Orders are exempted from levy of Town Duty, Octroi Duty, Terminal Tax and other levies of local bodies. The local Town/Municipal Body regulations at times, however, provide for such Exemption only on production of such exemption certificate from any authorized officer. Seller should ensure that stores ordered against Supply Order placed by this office are exempted from levy of Town Duty/Octroi Duty, Terminal Tax or other local taxes and duties. Wherever required, they should obtain the exemption certificate from the Buyer, to avoid payment of such local taxes or duties.

(b) In case where the Municipality or other local body insists upon payment of these duties or taxes the same should be paid by the seller to avoid delay in supplies and possible demurrage charges. The receipt obtained for such payment should be forwarded to the Buyer without delay together with a copy of the relevant act or by laws/ notifications of the Municipality of the local body concerned to enable him to take up the question of refund with the concerned bodies if admissible under the said acts of rules.

22. FALL CLAUSE:

(a) The price charged for the stores supplied under the Supply Order by the Seller shall in no event exceed the lowest prices at which the Seller sells the stores of offer to sell stores of identical description to any person/s/organization including the purchases of any department of the Central Government or any Department of State Government or any statutory undertaking of the central or state government as the case may be during the period till performance of all supply orders placed during the currency of the Supply Order is completed.

(b) If at any time, during the said period the seller reduces the sale price, sells or offer to sell such stores to any person/organization including the Buyer or any Deptt, of Central Govt or any Department of the State

Government of any Statutory undertaking of the Central or state Government as the case may be at a price lower than the price chargeable under the Supply Order, the seller shall forthwith notify such reduction or sale or offer of sale to the Director General of Supplies & Disposals and the price payable under the Supply Order for the stores of such reduction or sale or offer of the sale shall stand correspondingly reduced.

23. RISK & EXPENSES CLAUSE

(a) Should the stores or any installment thereof not be delivered within the time or times specified in the Supply Order documents, or if defective delivery is made in respect of the stores of any installment thereof, the Buyer shall after granting the seller 60 days to cure the breach, be at liberty, without prejudice to the right to recover liquidated damages as a remedy for breach of Supply Order, to declare the Supply Order as cancelled whether wholly or to the extent of such default.

(b) Should the stores or any installment thereof not perform in accordance with the specifications/parameters provided by the SELLER during the check proof tests to be done in the BUYER's country, the BUYER shall be at liberty, without prejudice to any other remedies for breach of Supply Order, to cancel wholly or to the extent of such default.

(c) In case of a material breach that was not remedied within stipulated time, the BUYER shall, having given the right of first refusal to the SELLER be at liberty to purchase, manufacture, or procure from any other source as he thinks fit, other stores of the same or similar description to make good :-

Such default.

In the event of the Supply Order being wholly determined the balance of the stores remaining to be delivered there under.

Any excess of the purchase price, cost of manufacturer, or value of any stores procured from any other supplier as the case may be, over the Supply Order price appropriate to such default or balance shall be recoverable from the SELLER. Such recoverable shall not exceed 10% of the value of the Supply Order.

24. FORCE MAJEURE CLAUSE

Neither party shall bear responsibility for the complete or partial nonperformance of any of its obligations (except for failure to pay any sum which has become due on account of receipt of goods under the provisions of the present Supply Order), if the nonperformance result from such force Majeure circumstances as Flood, Fire, Earthquake and other acts of God as well as was, Military operation, blockade, Acts or Actions of State Authorities of any other circumstances beyond the parties control that have arisen after the conclusion of the present Supply Order.

In such circumstances the time stipulated for the performance of any obligation under the present Supply Order is extended correspondingly for the period of time of action of these circumstances and their consequences.

The party for which it becomes impossible to meet obligations under this Supply Order due to Force Majeure conditions, is to notify in written from the other party of the beginning and cessation of the above circumstance

s immediately, but in any case, not later than 10 (Ten) days from the moment of their beginning

Certificate of Chamber of Commerce (Commerce and Industry) or other competent authority or organization of the respective country shall be a sufficient proof of commencement and cessation of the above circumstances. If the impossibility of complete or partial performance of an obligation lasts for more than 6 (six) months, either party hereto reserves the right to terminate the Supply Order totally or partially upon giving prior written notice of 30 (thirty) days to the other party of the intention to terminate without any liability other than reimbursement on the terms provided in the agreement for the goods received.
