Payment shall be released only after submission of documentary evidence of having Functional Service Centre.

17. **Service & Support**

**Escalation Matrix For Service Support :** Bidder/OEM must provide Escalation Matrix of Telephone Numbers for Service Support.

18. **Certificates**

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

### Additional Terms and Condition

1. Minimum 50% & 20 % local content required for qualifying the Class 1 & Class 2 local supplier.
2. Procedure for price preference shall be given based on the MII certificate for local content.
3. You should submit the necessary invoice after getting confirmation of acceptance of product by the end user.
