- 1. If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. - 4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity \div Original quantity) \times Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Buyer Added Bid Specific ATC

- **A)Guarantee/ Warrantee**:- The Tender shall be fully responsible for the manufacturers c omprehensive warranty with respect to proper design, quality, workmanship and proper functioning of the material for which these are intended, for a period of 12 months from the date of use or 18 months from the date of final acceptance of material at the ultimate destination. The supplier shall be responsible for any defects that they develop under the conditions provided for by the contract and under proper use, arising from faulty materials, design, or workmanship, and shall remedy such defects at his own cost when called upon to do so. If it become necessary for the supplier to replace or renew any defective portion of the goods, such replacement or renewal should be made by the supplier without any extra cost to WCL.
- B) **Fitment Guarantee:** Fitment guarantee to the effect that the items offered are exact r eplacement of the part numbers indicated in the NIT and will fit & function in the equipmen t without any modification/alteration is applicable
- **C) No Deviation Certificate:-** The bidder should declare that there should not be any deviation from the terms and conditions in the offer submitted by them against the present Bid
- **D) Delivery Schedule: Within 60 days** from date of issue of Contract
- **E) Security Deposit** :- 05% of Contract Value will be submitted online or through Bank Gu arntee in SFMS mode and refunded after completion of warranty/guarantee & submission of e-PBG.(Applicable for contract having value more than 02 Lakhs). State / Central Governm ent organizations / Public Sector Undertakings are exempted from submission of security D eposit. If fails to deposit security deposit then will be deducted from bill/invoice without any consent.
- **F) INSPECTION:** Final Inspection of the consignment shall be carried out at the destination stores, which will be arranged by the consignee on receipt of stores. WCL reserves the right to reject the goods which do not confirm to the specifications
- **G) Payment Terms :-** 100% payment within 21 days after receipt and acceptance of Mat erial by consignee and generation of CRAC & submission of security Deposit whichever is I ater
- H) **Price Fall Clause Certificate**: The bidder undertakes that it has not supplied / is not supplying similar products/ systems or sub-systems at a price lower than that offered in the present bid in respect of any other ministry/ department of the Govt. of India or a PSU and if it is found that at any stage that similar product/ systems or sub-systems was supplied by the BIDDER to any other Ministry/ Department of the Governement of India or a PSU at a lower price, then at that very price, with due allowance for the elapsed time, will be applicated be to the present case and the difference in the cost would be refunded by the BIDDER to the BUYER, if the contract has already been concluded
- I) Price Certificate: A Price Certificate shall be submitted along with the invoice / on the bo dy of the invoice as under: "This is to certify that the prices quoted by us for the off ered items are the lowest prices as applicable to any other Organization / Ministry / Department of the Govt, of India or Coal India Ltd. and /or its Subsidiaries or o ther PSU or any other private organization"

जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश का कोई भी बिडर इस निविदा में बिड देने के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो।बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्रवाई का आधार होगा।/In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
