Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

#### 2. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 50 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 50% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity ÷ Original quantity) × Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. #### 3. Generic

#### 1. DESCRIPTION & SCOPE OF WORK:

- (a) MAIN EQUIPMENT/ITEM/SYSTEM: Additional scheme paint items for Y-12653 of P-17A as per Tender
- (b) Shelf life: The supplied paints shall have a minimum shelf life of **twelve** months from the date of recei pt of material. Also, date of manufacturing of supplied paint material shall not be older than 3 months from date of receipt at MDL.

The process of preparation of gate passes fo r their tech. representative as per MDL terms is solely responsibility of the supplier. Proper care to be taken for preparation of passes so that the work on the ship should not hamper for want of supervision
- (d) Vendor to submit paint application/renewal/repair procedure of all its products used on Naval Ships.
- (e) Revalidation of paints: vendor has to revalidate the paint as & when required by MDL.
- 2. <u>Submission of Offer In Single Bid System</u>: Offer must be submitted in Single bid (Technical +Price Bid ).

The bidder shall ensure following are essentially included in bid:

- (i) Bidders / Suppliers should enclose additional documents as applicable to this tender.
- (ii) GST % for all quoted line items. line item wise on separate sheet.
- (iii) Prices for each of listed items has to be uploaded strictly in prescribed format provided on GeM port al. Bids received other than this given format will be rejected.
- **3. Pricing:** Prices shall be quoted for each line item of BoQ on all-inclusive basis as per terms and conditions of this tender as applicable for door delivery to MDL Stores. Quoted prices shall remain firm & fixed during currency of contract.
- 4. <u>Delivery schedule</u>: Delivery date of all deliverables shall be as indicated in Technical specification.

Part Delivery: Part Supplies, Part Payment are acceptable.

#### 5. LIQUIDATED DAMAGES (LD):

- LD clause shall be applicable as per GEM condition @ 0.5% per week for delay in supply of material. Note: LD is applicable with maximum ceiling as per GeM terms and conditions.
- **6.** <u>Guarantee/warrantee Requirement:</u> Vendor shall comply with the performance Guarantee format indic ated at relevant NCD's which are as follows:
  - i) Paint scheme for Underwater Hull and Fittings as per NCD -1481, Issue 3, May 201 1
  - (a) The supplied paints shall have a minimum life of twelve months from the date of receipt of material at MDI
  - (b) The Supplier cannot absolve their responsibility for warranty of material even though it is inspected by & approved by the inspection authorities.

- (c) If the defects are not remedied within a reasonable/stipulated time, MDL may proceed to rectify the defects at the supplier's risk & cost, but without prejudice to MDL's rights under the contract.
- (d) During the period of warranty / guarantee if any defect noticed in the equipment / item supplied, the supplier/ contractor will have to rectify such defects immediately at no extra cost to MDL.

#### 7. Performance Security Bank Guarantee (PSBG):

Performance Security is to be furnished within 15 days after notification of the award of contract and it sho uld remain valid for a period of 60 (sixty) days beyond the date of completion of all contractual obligations of the supplier, including warranty obligations. In case any delay in delivery, vendor shall extend the validity of performance security suitably.

- **8.** <u>Inspection</u>: Paints on delivery/ receipt at MDL Paint Stores along with co—relating Manufacturer's Test Cer tificates / Reports, guarantee certificate and Delivery Challans will be inspected by MDL (Inspection) & WO T (Mb). Other general conditions related to inspection of material are as under:
  - (a) Receipt Inspection: MDL with Warship Overseeing Team (WOT) shall carry out necessary inspection of the items on receipt in the MDL on the basis of appropriate MDL Inspection system requirement s & the Inspection documents submitted by suppliers. Any objection raised by MDL inspection tea m against quality of material or workmanship shall be satisfactorily corrected by the supplier at his expenses including replacement as may be required within shortest possible time within 30 days. I tems damaged during transit shall also be rectified or replaced by the supplier within shortest possible time.
  - (b) Rejection of the material: Any portion of the equipment found defective/rejected, the supplier shall collect the same at his cost from the MDL Yard, all incidental charges being born by supplier, (inclu sive of custom duty, if payable), within 30 days from the date of intimation to the supplier of such r ejection. The MDL reserves the rights to dispose-off the rejected item at the end of a total period of 90 days in any manner, to the best advantage to the MDL & recover storage charges & any conseq uential damages, from sale proceeds of such disposal.
- 9. <u>Indemnification</u>: The Bidder / Supplier / Contractor, his employees, licensees, agents or Sub-Supplier / Su bcontractor, while on site of the Purchaser for the purpose of this contract, indemnifies the Purchaser agai nst direct damage and/or injury to the property and/or the person of the Purchaser or that of Purchaser's e mployees, agents, Sub-Contractors / Suppliers occurring and to the extent caused by the negligence of the Bidder / Supplier / Contractor, his employees, licensees, agents or Subcontractor by making good such da mages to the property, or compensating personal injury and the total liability for such damages or injury s hall be as mutually discussed and agreed to.
- **10. Purchaser's Property:** All property (such as materials, drawings, documents etc) issued by the Purchas er or any other individual or firm on behalf of the Purchaser in connection with the contract shall remain confidential, being the property of the Purchaser and the Bidder/Supplier/Contractor shall undertake to return all such property so issued and will be responsible for any or all loss thereof and damage thereto resulting from whatever causes and shall reimburse the Purchaser the full amount of loss and damage.
