- 2. Bid will be received online by ACCEPTING OFFICER upto the date and time mentioned in the **NOTICE INVITING TENDER (NIT).** No tender/bid will be received in physical form and any tender/bid received in such manner will be treated as non bonafide tender/bid.
- 3. Bid will be opened on due date and time fixed for opening in the presence of tenderers/bidders or their authorized representatives, who have uploaded their bid and who wish to be present at the time of opening the bids.
- 4. Your attention is also drawn to instruction on filling and submission of tender attached herewith. You may forward your points on tender documents and/or depute your technical representative for discussion on tender/drawings and to clarify doubts, if any, on or before the bid submission start date. You are requested not to write piece meal points and forward your points duly consolidated before the bid submission start date.
- 5. Unenlisted contractors are required to submit the scanned copies (in pdf file) of documents required as per eligibility criteria mentioned in instructions for filling the tender documents and Appendix 'A' to NIT and tender fee on e-procurement portal and submit the physical documents in the office of HQ CWE SHILLONG within time limit specified in NIT. Inadequacy/deficiency of documents shall make the bid liable for rejection resulting in disqualification for opening of finance bid.
- 6. The lowest contractor would be required to deposit <u>PERFORMANCE SECURITY</u> within 28 days of receipt of letter of acceptance as per condition of 14A of IAFW-1815Z. Rate of Performance Security amount shall be 5% as stated Condition 14A.1 of IAFW-1815Z.
- 7. General Conditions of Contracts (IAFW-1815Z) and errata and amendments thereto, Schedule of minimum fair wages and are not enclosed with these documents. These are available for perusal in the Office of GE concerned and this office.
- 8. Enlisted contractors of MES shall submit the scanned copies (pdf file) of enlistment letter, tender fee and such other documents as mentioned in Appx 'A' to **NIT** on e-procurement portal and submit physical documents in the office of HQ CWE SHILLONG before date & time fixed for this purpose.
- 9. The contractors must ensure that the tender/bid on the proper form is uploaded in time as the Accepting Officer will take no cognizance of any quotations/offer received in any other electronic or physical form like email/fax/by hand/through post from tenderer/bidder even if they are received in time.

INSTRUCTIONS FOR COMPLETION OF TENDER DOCUMENTS TO BE COMPLIED WITH BY THE TENDERER(S)

- 1. <u>PERFORMANCE SECURITY</u>: The lowest bidder is required to give performance security as per condition 14A of IAFW-1815Z in favour of Accepting Officer in the form specified. However, rate of Performance Security amount shall be 5% as stated Condition 14A.1 of IAFW-1815Z. Failure of the lowest bidder in submission of performance guarantee within the stipulated time period shall attract penalties as given in condition 14A of IAFW-1815Z.
- 2. All contractors enlisted with any formation in MES who have deposited standing security deposit and have executed standing security bond fulfilling the eligibility criteria can participate in tendering without depositing EMD.

3. GENERAL INSTRUCTIONS FOR COMPLIANCE

- 3.1 The bid received only in the electronic form will be considered. All bids shall be submitted on www.defproc.gov.in portal. Documents should be scanned and forwarded in 'pdf' form and 'xls' form as indicated.
- 3.2 Bids shall be uploaded on <u>www.defproc.gov.in</u> portal on or before the bid closing date mentioned in the tender. No tender/bid in any other electronic or physical form like email/fax/by hand/through post will be considered.
- 3.3 Bid should be DIGITALLY signed using valid DSC. All pages of tender documents, amendments, corrections/alterations shall be signed/initialed by the lowest bidder after acceptance.
- 3.4 Drawings, if issued in physical form, must be returned duly initialed by the tenderer/bidder in separate envelope indicating his name and address.
- 3.5 The tender shall be signed, dated and witnessed at all places provided for in the documents after acceptance. All corrections shall be initialed. The Contractor shall initial every page of tender and shall sign all drawings forming part of the tender. Any tender/bid, which proposes alterations to any of the conditions whatsoever, is liable to be rejected.
- 3.6 In the technical bid, a scanned copy of Power of Attorney in favour of the person uploading the bid using his/her DSC shall be uploaded. In case the digital signatory himself is sole proprietor, scanned copy of an affidavit on stamp paper of appropriate value to this effect stating that he has authority to bind the firm in all matters pertaining to contract including the Arbitration Clause, shall be attached in 'pdf' form. In case of partnership concern or a limited company, digital signatory of the bid/tender shall ensure that he is competent to bind the contractor (through partnership deed, general power of attorney or Memorandum and Articles of Association of the Company) in all the matters pertaining to the contracts with Union of India including arbitration clause. A scanned copy of the documents confirming of such authority shall be attached with the tender/bid in 'pdf' form, if not submitted earlier. The person uploading the bid on behalf of another partner(s) or on behalf of a firm or company using his DSC shall upload with the tender/bid a scanned copy (in 'pdf' form) of Power of Attorney duly executed in his favour by such other or all of the Partners(s) or in accordance with constitution of the company in case of company, stating that he has authority to bind such other person of the firm of the Company, as the case may be, in all matters pertaining to the contract including the Arbitration Clause.
- 3.7 Even in case of Firms or Companies which have already given Power of Attorney to and individual authorizing him to sign tender in pursuance of which bids are being uploaded by such person as a routine, fresh Power of Attorney duly executed in his favour stating specifically that the said person has authority to bind such partners of the Firm, or the Company as the case may be, including the condition relating to Arbitration Clause, should be uploaded in 'pdf' form with the tender/bid, unless such authority has already been given to him by the Firm or the Company. It shall be ensured that power of attorney shall be executed in accordance with the constitution of the company as laid down in its Memorandum & Article of Association.
- 3.8 Hard copies of all above documents should be sent by the contractor to the Tender issuing authority well in advance to be received before the date & time fixed for the same.
- 3.9 Bid (Cover 1 & 2) shall be uploaded online well in time.
- 3.10 The contractor shall employ Indian Nationals after verifying their antecedents and loyalty. Attention is also drawn to special condition 3 referred hereinafter and also conditions of IAFW-1815Z.
- 3.11 Tenderers/bidders who uploaded their priced tenders/bids and are desirous of being present at the time of opening of the tenders/bids, may do so at the appointed time.
- 3.12 The tenderer/bidder shall quote his rate on the BOQ file only. No alteration to the format will be accepted, else the bid will be disqualified and summarily rejected.
- 3.13 In case the tender/bidder has to revise/modify the rates quoted in the BOQ (excel sheet) he can do so only in the BOQ, through www.defproc.gov.in website only before the bid closing time and date.

4. <u>REVOCATION/REVISION OF OFFER UPWARD/OFFERING VOLUNTARY REDUCTION, AFTER OPENING OF COVER-II BY ANY BIDDER</u>

In the event of any tenderer/bidder revoking his offer or revising his rates upward/ offering voluntary reduction, after opening of Cover-II, his offer will be treated as revoked and the Earnest Money deposited by him shall be forfeited. In case of MES enlisted Contractors, the amount equal to the Earnest Money stipulated in the Notice of tender, shall be noticed to the tenderer/bidder for depositing the amount through MRO. Bids of such Contractors/bidders shall not be opened till the aforesaid amount equal to the earnest money is deposited by him in Govt Treasury. In addition, bids of such tenderer/bidder and his related firm shall not be opened in second call or subsequent calls. Reduction by the tenderer/bidder on the freak high rates referred for review shall not be treated as voluntary reduction.

5. **CPM (Critical Path Method)**

- 5.1 The project planning for work covered in the scope of tender is based on CPM.
- 5.2 The tenderer/bidder is expected to be fully conversant with the CPM technique and employ technical staff who can use the technique in sufficient details. Sufficient books and other literature on the subject are widely available in the market which the tenderer/bidder may make use of.
- 5.3 The tenderer's/bidder's attention is drawn to special condition of the tender regarding preparation of the detailed network analysis and time schedule for the work and his liability for employing sufficient resources to adhere to this schedule. Any inability on the part of the tenderer/bidder in using the technique will be taken as his technical inefficiency and will affect his class of enlistment and future prospect/invitation to tenders for future works.
- 5.4 Department may issue amendments/errata in form of **CORRIGENDUM** to tender/revised BOQ to the tender documents. The tenderer/bidder is requested to read the tender documents in conjunction with all the errata/amendments/corrigendum, if any, issued by the department.

- 2. The work is estimated to cost as indicated in aforesaid Appendix 'A'. This estimate, however, is not a guarantee and it is merely given as rough guide and if the work cost more or less, the tenderer/bidder will have no claim on this account. The tender shall be based as mentioned in aforesaid Appendix 'A'.
- 3. The work is to be completed within the period as indicated in aforesaid Appendix 'A' in accordance with the phasing, if any, indicated in the tender from the date of handing over site, which will be on or about two weeks after the date of Acceptance of tender.
- 4.  - (c) Scanned copy of DD / Bankers Cheque toward cost of tender and EMD instrument in case SSD bond is not signed at the time of registration.
 - (d) Any other document required as described in this Appendix.
- 5. Contractors not enlisted with MES will be required to upload following documents in Cover 1 for checking eligibility:-

- 11. In case an unenlisted contractor is already executing works in MES, he shall not be considered eligible for the subject tender if the total value of such works is more than twice the tendering limit of the MES Class of contractor for which it is eligible. 1. GENERAL

1.1 These conditions shall be read in conjunction with General Conditions of Contract 1815-Z forming part of this contract.

2. SECURITY PASSES ETC

- 2.1 The contractor's attention is invited to condition-17 of IAFW-1815-Z. He shall employ person(s) of only Indian Nationality after verifying their antecedents and loyalty. The contractor shall on demand by the Engineer-in-Charge, submit a list of his agents employees, and work people concerned and shall satisfy the Engineer-in-Charge as to the bonafides of such people.
- 2.2 The Engineer-in-Charge shall at his discretion have the right to issue passes as per rules and regulations of the installation/ area, in force, to control the admission of the contractor, his agents, employees and work people to the site of the work or any part thereof. Passes shall be returned at any time on demand by the Engineer-in-Charge or the authorities concerned and in any case on completion of work.
- 2.3 The contractor and his agents, employees, work people etc shall observe all the rules promulgated by the authority controlling the Installation/area in which work is to be carried out e.g. Prohibition of smoking and lighting, fire precautions, search of person on entry and exit keeping to specific routes, observing specified timings etc. No extra claims/payment shall be admissible for any man hours etc lost on this account.

- 10.1 Proprietary branded materials such as paint and the like, quantities of which cannot be checked after incorporation in work, shall when collected at site, be recorded in Measurement Book and signed by MES representative and the contractor or his authorised representative.
- 10.2 He shall obtain/procure proprietary branded materials from authorised stockists. The contractor shall produce original receipt vouchers showing quantity and quality of the materials which shall comply with the specifications. These voucher shall be endorsed dated and initialed by the BSO/EIC giving the CA No and Name of work and certified true copy of each such vouchers signed by the BSO/EIC and the contractor shall be kept on MES record. Contractor shall produce cash purchase vouchers for the entire quantity procured in respect of fittings and newar and other items to the GE for his verification and record.
- 10.3 The contractor shall ensure that the materials are brought in packed original sealed containers/ packing bearing manufacturer's marking/brands etc.
- Materials brought at site shall be stored as directed by the Engineer-in-Charge and those already recorded in MB shall be suitable marked for identification.
- 11. <u>SIGNING OF CONTRACT DOCUMENTS:</u> The person signing the tender on behalf of a firm shall attach with the tender proper power of attorney duly executed in his favour by such other person or the firm as the case may be in all matters pertaining to the contract including the arbitration clause.
- 12. <u>PERIOD OF KEEPING TENDER OPEN:</u> The tender shall remain open for acceptance for a period of 60 (Sixty) days after the date of submission.
- 13. <u>SECURITY OF CLASSIFIED DOCUMENTS:</u> Contractor's special attention is drawn to condition 3 of IAFW-1815-Z (General conditions of contract). The contractor shall not communicate any classified information regarding the work either to sub-contractor or others without prior approval of EIC. The contractor shall not make copies of design drawings and he shall return all documents on the completion of work or the earlier determination of the contract. The contractor shall alongwith final bill attach a copy of receipt from the EIC in respect of his having returned the classified documents as per condition 3 of IAFW-1815-Z.

14. RELEASE OF PERFORMANCE SECURITY DEPOSIT

- 14.1 Refer Conditions 14A and 34 of IAFW-1815Z.
- 14.2 The contractor has to deposit performance security for the contract for a period equal to the sum of contract period as given in the contract and defect liability period (condition 20 of IAFW-1815Z) and the same shall be released after expiry of defect liability period.
- 15. <u>TESTING OF MATERIALS</u>: Where testing of contractor's materials is carried out in Zonal/ National Test House/SEMT Wing/Engineering College Govt Site Lab, the contractor shall be liable to pay the testing charges as applicable and shall be recovered from the contractor's running payment/final bill as the case may be.

- 1. <u>GENERAL</u>: Specifications required to be followed in the work shall be as shown in drawings. Particular specifications part I and part II given here-in-after shall supplement to and are to particularise, amend or emphasis the aforesaid specification in the drawings. If any provisions in the particular specifications given here-under are at variance with provisions in the drawings, the provision in particular specifications shall take precedence over particular specifications in case of any discrepancy.
- 2. <u>DRAWING</u>: Drawings applicable to this contract are mentioned in Schedule 'A' and in particular specifications. Part II and shall be inclusive of amendments up to date. Any drawing mentioned in any drawing or in particular specification itself and inadvertently not included in Schedule 'A' or in particular specifications shall also form part of this contract.
- 2.1 Details of Schedule of quantities wherever shown on drawings are for guidance only and no claim what-so-ever for any omission inaccuracies, discrepancies therein shall be entertained.
- 3. <u>MATERIALS</u>: All materials to be supplied/incorporated in supplies by the contractor shall be new.
- 4. <u>STEEL SECTIONS</u>: All mild steel and iron work shall be of ordinary quality Fe-290 (Gde E- 165).
- 4.1 All finished steel shall be well and clearly rolled to the dimensions, sections and weight as specified in relevant IS.
- 4.2 The finished materials shall be free from cracks surface flaws, laminations, rough, jagged and imperfect edges and all other, harmful defects.
- 5. <u>ELECTRODES</u>: Electrodes for metal welding of MS shall be as per IS-814. The mechanical properties of the weld deposit shall be such as to satisfy all the requirements of the parent metal.
- 6. <u>HOLES</u>: All holes shall be accurately marked and drilled.
- 7. <u>WELDING</u>: Unless specifically mentioned, otherwise, fillet weld shall be provided. Welded, joints shall be free from defects that would impair the service performance of the articles. - 10. <u>PLYWOOD</u>: The plywood shall be ISI marked and shall be approved by GE It shall be of grade "BWR". The quality requirements of each face of the plywood shall be of type 'A' (Commercial facings). It shall be uniform in thickness, free from warps and cracks. The edges of the plywood shall be trimmed square. The thickness given is "NET" and no tolerance is allowed. MAKE: GREENPLY INDUSTRIES LTD (PLY & BOARD DIVISION)/KITPLY/CENTURY/ NATIONAL PLYWOOD INDS PVT LTD/ARCHID PLY.
- 11. <u>Decorative Plywood.</u> These shall also be ISI marked and shall be approved product of BIS, where ever in drawings decorative veneers shown in drawings over plywood, these shall be decorative plywood on one face/both faces as per drawing. Decorative veneers shall be of teak wood species. The adhesive for bonding shall be synthetic resin conforming to IS-848. The thickness of plywood shown in drawing is exclusive of decorative veneers. The tolerance on the thickness shall be not more than (+) 10% and (-) 5%.

- 13. TIMBER
- (a) All woodwork shall be in teakwood if not specified otherwise in these tender documents elsewhere. Timber shall be first grade kiln (plant) seasoned teakwood as per IS 1331-1971 with moisture content permissible as per IS 287: 1973.
- (b) Where teak wood is indicated on drawing or specified hereinafter it shall be best quality teak wood as above, well seasoned as per sample kept in GE's Office and as approved by Garrison Engineer. Where no wood is indicated in drawings, teak wood shall be used except where specifically indicated otherwise in these specifications. All timber shall be the best of its kind. It shall be natural growth, free from shakes, knot, dot, cracks, borer holes, soft spots, termite attack & all other defects & blemishes. - (i) are not likely to become loose or are dead knots.

However for wooden members where any dimension has been specified to be 20mm or more tolerance of 1 mm will be allowed in respect of each of such dimension of the member.
- (e) Every plank shall be in one length and no joints shall be permitted.
- (f) Width of Plank in timber: Except where planks are specifically indicated on drawings to be in one piece, width of planks shall be as under:-

The sizes/diameter etc shown are external sizes/diameter. The thickness of pipe shall be 1.60 mm unless mentioned otherwise elsewhere. Conduits shall be free from all manufacturing defects etc. No tolerance in diameter as well as thickness of conduit shall be allowed. Conduit shall be of class 'B'.
- 15. <u>Newar:</u> Newar shall be of nylon and shall be of new white/light coloured nylon and not made out of recycled nylon. Width of nylon newar shall be 50mm.
- 16. <u>PVC Hard Rings</u>: These shall be of best quality and shall be of approved shape and sizes. Rubber/Bakelite rings are not acceptable.
- 17. <u>Shellac</u>: Shellac shall be pure varying from pale orange to yellow colour, free from resin and dirts.
- 18. <u>Methylated Spirit</u>: Methylated spirit shall be free from any type of contamination.
- 19. French Polish: French polish shall be of any of the following makes:-
 - (i) Shalimar (ii) Berger (iii) Rajdoot.
- 20. NAILS AND SCREWS
- 20.1 Iron mongry shall be fixed with steel screws, round and flat headed as required and approved by GE. Unless otherwise specified brass articles shall be fixed with brass screws. Aluminum articles shall be fixed with cadmium plated steel screws. Wooden members/articles where shown in drawings/required shall be fixed with steel wood screws conforming to IS-451. Type and size shall be as directed but shall be cadmium plated. Screws shall not be thinner than designation and of length not less than twice the thickness of boards members to be fixed. Screws and nails shall be of type and size as approved by GE.
- 20.2 Screws and nails shall be of type and size as approved by GE.
- 21. <u>DOWELS AND PINS</u>: Dowels and pins for securing mortice and tenon joints where required shall be of solid bamboo of good quality.
- 22. <u>WORKMENSHIP GENERALLY</u>
- 22.1 The work shall be executed in workmen like manner. Every part shall be true and well fitted and shall confirm to the best standard of workmanship obtainable from a high class cabinet maker.
- 22.2 Wood work shall be wrought on all faces unless otherwise specified.
- 22.3 The work "framed" as applied to wood work shall be understood as including all the best known methods of jointing wood work together by means of mortice and tenon joints, dovetailed joints or similar joints shall be applied.
- 22.4 Framed joints shall be made to fit properly without any welding /filling or making up and made so as to be hidden from view.
- 22.5 All framed wood work shall be framed & fitted together first by fevicol or other equal adhesive and then the joints pinned except for rails of bed and charpoys. Joints of tongue and grooved or rebated joinery shall be glued when putting together.
- 22.6 All framed wood work and paneling shall be put framed together at 10 mm centre. No single plank of the shelf shall be fixed, removed and replaced by the contractor.
- 22.7 Wherever indicated shelves and bearers shall be fixed with screws at 10 mm centre to centre. No single plank of the shelf shall be fixed with less than two numbers of screws at each end.
- 22.8 All wood work open to view either from top, bottom or from sides, shall be finished to a smooth, true or clean surface with sand paper. However, ends of legs such as of chairs, tables, beds charpoys etc, which are in contact with the floor shall not be sand papered.
- 22.9 Corners of articles, where indicated shall be slightly rounded.
- 22.10 The joints (except joints of panels) in wood work where not shown on drawings shall be mortice and tenon for scantling and styles and dovetailed for drawer etc.

- 22.11 In length, scantlings, planks, fillets, boarding, shall be in one piece. The width of planks/boards shall be as shown on drawings where, however, width of planks is not indicated, planks shall be in one piece for width upto 30 cm of member and where width of member exceeds 30 cm, planks of equal width of not less than 150 mm shall be provided.
- 22.12 Particle boards, plywood, plastic laminated, conduits, etc. wherever to be used shall be in one piece. However, where members are of such size which cannot be obtained in one piece from any size of particle boards, plywood, laminated sheets etc. manufactured in the country, the member will be provided in more than one piece of equal sizes (maximum obtainable sizes) as approved by GE.
- 22.13 The grain/texture of teak ply/particle boards/laminated sheets shall be lengthwise or vertical as indicated on drawings or as directed by the EIC.
- 23.1 FINISHING. All articles of furniture shall be finished as described here-in-after.
- 23.2 <u>FRENCH POLISH</u>. French polishing shall be carried out as specified here-in-after of tint/shade as directed and approved by GE. All wooden surfaces of timber exposed to view shall be French polished if nothing else is indicated in drawings and these tender documents elsewhere.
- 23.3 <u>PREPARATION OF SURFACES</u>. Remove plane marks with a wood scraper and smoothen surfaces with paste and sand paper No 2, fill and stop holes with paste filler prepared by mixing plaster of paris and water to a creamy consistency and adding raw sienna in quantity required to obtain the desired colour to be base. When the surface has been dried up, wipe off and set aside for 24 hours for the surfaces to harden. Rub surfaces with sand paper No 1, until it is thoroughly smooth and then clean off.
- 23.4 <u>POLISHING.</u> Prepare the polish in the proportion of 1 Oz. of shellac to 4 Oz. of methylated spirit. Shellac crystals shall be washed in luke warm water, remover dirt and dried before mixing with methylated spirit. Shake the mixture, until the ingredients are completely dissolved.
