1. If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. 2. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

7. Reverse Auction would be conducted amongst first 50% of the technically qualified bidders arranged in the order of prices from lowest to highest. Number of sellers eligible for participating in RA would be rounded off to next higher integer value if number of technically qualified bidders is odd (e.g. if 7 bids are technically qualified, then RA will be conducted amongst L-1 to L-4). In case number of technically qualified bidders are 2 or 3, RA will be between all without any elimination. If Buyer has chosen to split the bid amongst N sellers, then minimum N sellers would be taken to RA round. In case Primary products of only one OEM are left in contention for participation in RA based on lowest 50% bidders qualifying for RA, the number of sellers qualifying for RA would be increased to get at least products of one more OEM (directly participated or through its reseller) if available. Further, if bid(s) of any seller(s) eligible for MSE preference is / are coming within price band of 15% of Non MSE L-1 or if bid of any seller(s) eligible for Make in India preference is / are coming within price band of 20% of non MII L-1, then such MSE / Make in India seller shall also be allowed to participate in the RA process.

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

a) Stores will be supplied within the stipulated date of delivery given in the supply order. No extension will be granted except in the case of natural calamity, factory lock out, etc. or this is beyond the control of supplier. In such cases supplier shall/should approach this office well in advance but not later than the date for consideration towards extension of date of delivery.

b) The consignee reserve the right to reject the stores in case these are found not conforming to specification/sample prescribed. Rejected store will have to be collected by you at your risk and cost within 15 days of receipt information failing which rejected stores shall become the property of the Project or any amount realized on account of their disposal.

c) During evaluation and comparison of bids, the buyer may, at his discretion, ask the bidder for clarification of his bid. The request for clarification will be given in writing and no change in prices or substance of the bid will be sought offered or permitted. No post-bid clarification on the initiative of the bidder will be entertained.

d) Supply orders are liable for cancellation without assigning any reasons prior to actual supply of stores within the time specified for supply in the order.

e) Rate/prices quoted should be all inclusive and delivered up to 1081 Field Workshop, GREF C/o 56 APO, Pithoragarh (Uttarakhand)-262501.

#### 19. **Period of Delivery.**

a) The supply is to be completed within **45 days** from the date of issue of Supply Order.

b) If the stores are not supplied within the stipulated period of supply order. The supply order is liable to be cancelled without any obligation/compensation for the expenditure incurred by firm in connection with the supply order.

c) In case of delay in supply of stores, firm will apply for time extension, if required, along with the reasons within the validity of delivery date for consideration. Accepting officers reserves the right for accepting/ rejection of request for extension of delivery.

#### 20. **Liquidated Damages:-** If contractor/ seller fails in the performance o

f the contract within the time fixed under this contract or any other extension thereof, the contractor/seller shall be liable to pay as agreed liquidated damages and not as penalty a sum equivalent to 1/2 % (half percentage) of the contract price of the items per week of such delay or part thereof. The supplier's liability for liquidated damages shall not exceed 10 % (Ten percentages) of the contract price of items delay. If the delivery delayed beyond 5 weeks, the purchasers may at his own option terminate the contract. If any delay in supply arises from any causes which the purchaser may deem to be on reasonable ground such as wrong suppliers or losses in transit from the main suppliers to the supplier or any cause beyond the control of supplier/seller, such as strikes, lock outs, fire acts of GOD or similarly eventualities constitution the recognized FORCE MAJEURE such additional time as any be considered under the circumstances of the case by the purchaser, may be allowed by him, provided that an intimation of the circumstances is given by the supplier/seller to the purchaser not later than 10 days of their happening.

21. **Inspection:-** The stores supplied will be inspected by the board of officers detailed by the Accepting Officer or any officers detailed by TF/CE at the time of delivery and should be strictly according to specifications/satisfaction of the Inspecting Officer, the stores are liable to be rejected and will have to be replaced without any additional cost.
22. **Payment:-** Full payment will be made on receipt of entire consignment in good condition by the consignee and on 30 days' credit basis against pre-received bill.
23. The Details of firm and certificate as per format enclosed at Appx 'A' to be uploaded at the time of bid submission.
