SCOPE OF WORK :

The Contractor shall be responsible for Maintenance the Cable Fault Locating Machine and vehicle of appropriate along with experienced technician, helpers and driver etc. by their own end for locating the 33 KV / 11 KV / LT Cable Fault on round the clock basis.

The Contractor shall be responsible for providing the Cable Fault Locating Machine of appropriate and latest version & specifications along with experienced technician, helpers and driver etc. by their own end for locating the 33 KV / 11 KV / LT Cable Fault on round the clock basis.

Pin pointing within one meter of cable fault, exposing the same in the underground HT / LT cable (33 KV / 11 KV / LT) including cutting of the Faulty Cable, its meggering & sealing of healthy cable.

In addition to locating and pin pointing of cable faults, the contractor shall also be responsible for digging of cable trench of suitable size so as to enable making of cable joints (one or two straight through joints depending on the requirements), it shall also include cutting of the faulty cable in sufficient length.

Road cutting & digging thereof so that cable may be taken out for jointing work. Dressing of road as may be required at various places of EUDC-Technical, Noida The outdoor/Indoor termination kit, straight through jointing kits and cable jointer shall be provided as Item Rate BOQ.

WORK SCHEDULE:

- i) The work of pin pointing and locating cable in fault in underground HT / LT cables shall be executed/started by the contractor within 2 (two) hour of giving call or message to this effect. The contractor may be required to attend more than one fault simultaneously JE/SDO will call/sms to the contractor about the fault and will keep a record of screen shot of call/message log. Log details will also be maintained by contractor and will be attached with bills produced for payment.
- ii) The contractor will dig the cable trench in such a manner so as to avoid any damage to the cable or any other public utilities existing under the ground.
- iii) The fault location shall to be done throughout the entire link to pin point all the faults and making its possible to revive the link in such a manner so that the link under breakdown gets operational within minimum period to time.
- iv) the contractor shall be required to carry out the fault location work for 24×7.
- v) **In the event of inaccurate pin point/exposing the contractor will have to bear the expenditure incurred in locating the fault. For inaccurate pin pointing exposing, a flat 5% penalty of the job work will be deducted from the bills of contractor.**
- vi) The Cable fault locator machine, other tools/ equipment's and testing facilities etc. shall be provided by the contractor. It shall be responsibility of the contractor to arrange experienced technical staff and labours required for the tendered work at their own cost.
- vii) The contractor shall be fully responsible for safety of their gang as for payment of compensation in case of any accident during the execution of the work, including third risk/claim as legally applicable. The engineer of contract shall have full right for recovery against such claims/compensation from the contractor.
- viii) The contractor will complete the work within 12 (twelve) hours after reporting at site of fault. For delay in completing the work a penalty @ 5% of the job work per hour for first two hours and @ 3% for subsequent hours up to a maximum of 25% of the job work will be deducted from the bills of the contractor.

- 9- Bidder will have operated with single fault locating machines simultaneously round the clock.
- 10- Fault locating machine in time of need will have independent manpower to operate.
- 11- The quantity maximum vary upto any extent within Agreement Value & Agreement value may vary upto any extent with approval of M.D., P.V.V.N.L., Meerut.
- 12- The contact of person to whom the Executive Engineer will inform the faults shall be informed after signing of this agreement.
- 13- Monthly report submission with GPS Location Photograph (Before and After) with list of faults in Pendrive at circle office & Nodal division offices for payment, cost of which will be borne by the contractor.
- 14- The bidder shall procure the jointing kits from Raychem/Denson/3M make, strictly in accordance with the GTP approved by PVVNL, Meerut. The bidder shall arrange for inspection/testing of the materials as per departmental rules S.E. (DQC) PVVNL Meerut through the Superintending Engineer. After testing, the materials will be handed over in a single lot to the engineer nominated by the Superintending Engineer.
- 15- The jointing kit / work will have a warranty period of 12 months. If the jointing kit damaged during the warranty period, the contracting agency will replace the jointing kit (including fault location and rectification) free of charge.
- 16- After locating the fault and resolving the issue, the work slip for each fault must be signed by the concerned junior engineer and attached to the monthly report in photocopy and pen drive.
- 17- The work will be done **till dated 31.03.2027** from the date of agreement with this quantity. If the quantity of work remains till 31.03.2027, then in that case also the contract will be terminated based on the quantity of work and amount utilised till 31.03.2027.
- 18- In case the contracted quantity of work is completed before the completion of the contract period, in order to maintain continuity of work, the quantity of work and amount shall be extended as per rules subject to the stipulated rates, terms and conditions.

Taxes: -

- 1- Rate given in rate schedule is inclusive of all G.S.T., other duties, taxes, fees, octroi and other levies, materials, labour to & fro transportation of material and labour charges etc.

Others Terms & Conditions: -

- 1- Any type of NOC for the completion of work will be arranged by the bidder itself only, Department will not be liable for these NOC.
- 2- The charges for Road cutting, Forest Clearances charges, land lease charges or from any other agency which are required to complete the work shall be paid by the contractor.
- 3- Any loss or damage to any of the public utilities shall be repaired by the contractor at his own cost.
- 4- The Contractor shall have to arrange all carriage facility including transportation cartages, man power T&P etc. on its own cost.
- 5- The Contractor shall make adequate Arrangement for proper Handling of Material to avoid any Damage/ Loss/Accident etc. of any kind.
- 6- No T&P will be provided by the department. The Contractor shall arrange all the T&Ps. Equipment's. Welding set, generator set etc. required for carrying out the above work at his own cost.
- 7- The contractor shall be fully responsible for any loss/thefts/damaged/accidents the material of the departments and accordingly, he shall have to keep adequate watch and ward to avoid any loss/thefts /damages/accidents etc. to the material of the PVVNL.

- 8- The contractor shall be fully responsible for any accident/loss to the persons(s) working with/under him and shall have to pay compensation in accordance with the prevailing rules & regulations of Govt./ PVVNL.
- 9- During the period of work in progress, the Contractor shall have to provide lighting arrangement sign board etc. or necessary precautionary arrangement so that accident/ damages/ losses to the public/ manpower of the contractor/ department etc. are avoided.
- 10- All the charges on account of damages/losses/thefts etc. involved under the condition laid down above shall be borne by the contractor.
- 11- Proper skilled staff included Supervisor capable for execution of the above work shall have to be arranged by the contractor. The safety of labour while at work shall be the responsibility of the contractor and any compensation to be paid to them on any account, whatsoever, shall also be responsibility of the contractor UPPCL/ PVVNL shall not be liable for any such compensation etc.
- 12- The contractor shall have to execute the work within the stipulated time as provided in the order (work-slip) to be issued by the competent authority.
- 13- Cable Fault Locator Equipment mounted on a vehicle, Cable & Jointing Kits will be provided as per Rate Schedule, except bricks, cement, coarse sand, river sand, brick ballast, stone ballast, all type of clamps, nuts & bolts and other petty items etc. if required for execution of work, which will be arranged by the contractor at his own cost.
- 14- The Proper Shut down will be given as required by the Contractor time to time as per site/system Requirement and Availability by the SDO/JE of the Concern Area.
- 15- The work is to be done by the Contractor under the Direct Supervision of concerned S.D.O (Distribution).
- 16- All General Conditions of Contract laid down in Form 'A' & Form 'B' of UPSEB/ UPPCL/PVVNL shall also be applicable.
- 17- The Contractor shall have to deposit a contract performance guarantee @ 10% of the value of Awarded Contract in the form of FDR/E-BG pledged in favor of SE EUDC-TECHNICAL, NOIDA at the time of agreement/before the agreement validity of Security amount shall be 12 months. Security Money shall be returned/refunded after work completion and NOC issued by the concerned division.
- 18- Income Tax, GST TDS, Labour Cess & Other taxes shall be deducted from the bills of the Contractor as per rules prevailing at the time of payment.
- 19- Notwithstanding the agreement executed with the Contractor, the Engineer of the contract always reserves the right to get the work done by department or through any other agency. The Contractor shall have no objection and claims over such work.
- 20- The agreement can be terminated by the Superintending Engineer of the contract at any time without any notice in the event of un-satisfactory performance of the contractor. This is however, without prejudice to the other terms & conditions of the agreement.
- 21- If the Contractor Fails to execute the work within the stipulated period, the order placing authority reserve the right to get the work done departmentally or through any other agency. The Excess expenditure, if any, incurred in this connection plus 15% supervision charges shall be debited from the Contractor and it will be recovered from the Security Amount/Running/Pending Bills or through any other credit pending with UPPCL of the Contractor.
- 22- For any dispute arising out of the contract, Chief Engineer (Dist.), PVVNL, Noida Zone, Noida shall decide the dispute and his decision shall be binding on both the parties.
- 23- The material shall be guaranteed for satisfactory performance as per guarantee clause of Form B. The material damaged/ Defective during guarantee period will be replaced free of cost.
- 24- The expenditure of the referred work should be settled from the funds provisioned under O&M item F.Y. 2026-27.
- 25- **The details of the work to be done by the executing organization will be kept in the following format and after getting the signatures of the Junior Engineer, Sub-Divisional Officer and Executive Engineer related to this particular area, advance action related to the payment of will be ensured.**

If payment is made without recording the details of work in the measurement book as per the above format, then the concerned Executive Engineer (Technical) who is also the Drawing and Distribution Officer will be personally responsible.

- 26- The running payment of work can be done through ERP on the above format/details signed by the Junior Engineer, Sub-Divisional Officer and Executive Engineer related to the field of work will be done by nodal Executive Engineer (Technical) after measurement of work and availability of funds.
- 27- Full payment will be made only after the work is inspected by a third party.
- 28- The bills in triplicate duly Pre-receipted with the original work-slip shall be submitted by the Contractor to the Engineer of the Contract for Payment.
- 29- The work shall be carried out as per general condition of contract Form 'A' & its addenda.
- 30- All the work (erection, grouting etc.) will be completed as per RESPO Norms.

- 31- As per the requirement of the work, out of the contracted quantity, the work can be done in the work area of any division/area after the permission of the Superintending Engineer, Electricity Urban Distribution Circle-I, Noida.
- 32- The jointing kit provided by the firm will be ensured by the concerned Executive Engineer that it conforms to the ISI/ISS specifications and is of '**Raychem/3M/Denson**'.
- 33- In case of fault, the Sub-Divisional Officer related to the work area will inform the Executive Engineer and only after the Executive Engineer issues 'Work Permission', the concerned contractor should attend to the fault.
- 34- Under the tender specification, after fault pin-pointing, exposing the fault (by digging) and after completion of cable jointing work, back-filling etc. were mentioned.
- 35- In case the tenderer quotes impractical rates for the work and does not enter into a contract, action will be taken to confiscate the earnest money of the tenderer and blacklist the firm.
- 36- The Tender Work will be bifurcated/allotted within Two firms / more than two firms on L-1 quoted rates as required for timely completion the works by the SE EUDC -Technical, Noida at the time of agreement.
