If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. 3. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

#### 10. **Inspection**

**Pre-dispatch inspection at Seller premises (Fee/Charges to be borne by the BUYER):** Before dispatch, the goods will be inspected by Buyer / Consignee or their Authorized Representative or by Nominated External Inspection Agency (independently or jointly with Buyer or Consignee as decided by the Buyer) at Seller premises (or at designated place for inspection as declared / communicated by the seller) for their compliance to the contract specifications. - Vendor to get the despatch clearance form BHEL Bhopal before sending the materials.
- Final acceptance will be done at BHEL Bhopal only after duly inspection by BHEL representative.
- BHEL reserves the right to reject any or all bids, or cancel/withdraw the Invitation for Bids /NIT without assigning any reason whatsoever. In such cases, no bidder or intending bidder shall have any claim arising out of such action.
